- To assist in the prevention of illegal or unsportsmanlike practice by anyone in the practice of professional hunting or by anyone engaged in the sports of hunting, fishing or photography;
- To promote and safeguard the interests of all members of this corporation;
- To endorse and foster a code of business ethics in accord with ethical standards and the laws and regulations of the State of Alaska.
